## WEDMORE PARISH COUNCIL

MINUTES of a Meeting of the **FINANCE and GENERAL PURPOSES Committee** held at the Council Rooms, Grants Lane, Wedmore on **Wednesday 1st December 2021 at7.15 pm**

- 1. **ELECTION OF CHAIRMAN** Proposed by Cllr Worrall and seconded by Cllr Cousins that Cllr Costello be elected Chairman. This was agreed.
- 2. **APOLOGIES FOR ABSENCE** Cllrs J Farley, A Smith
- 3. **REQUEST FOR DISPENSATION** The 6 members present had requested the Clerk (as per Standing Orders) to grant a dispensation for them to discuss and set the Budget and Precept for 2022/2023. A request form was completed by members present, approval was given and the form was signed by the Clerk
- 4. **MINUTES OF THE LAST MEETING** The minutes of the meeting held on 2<sup>nd</sup> December 2020 were approved and signed by the Chairman
- 5. **MATTERS ARISING** None
- 6. **BUDGET AND PRECEPT 2022/2023** Cllr Mulliner noted that the precept had remained unchanged for the past five years and with all the extra housing in the village, perhaps it should be raised due to extra responsibilities and costs. Cllr Kirley said he would propose the precept be raised to £75k providing there was no impact on the council tax payers. This was seconded by Cllr Worrall and agreed. The Clerk would contact the Chief Accountant at Sedgemoor to find out what the likely impact, if any would be. The Clerk had previously circulated a proposed budget for the coming year and had taken into account the proposed allotment rent increase and costs for a new website. CIL funds were at £98k and it was already agreed to grant £100k towards a new health centre. Cllr Costello said there was a possibility of land becoming available at Blackford to create a safe footpath for students at the school. This would require some funding from the Council and would be an ideal opportunity for CIL funding. Cllr Worrall reminded the meeting that funds were being held at Sedgemoor to provide additional work to affordable housing. The proposed budget as circulated was agreed.
